Prospective bidders shall comply with the requirements of the Local Public Contracts Law N.J.S.A. 40A:11-1 et. seq. as supplemented and amended; Disclosure Notice (P.L.1977, c33) N.J.S.A. 52:24.1, and with the requirements of the P.L. 1975C.127 regarding Affirmative Action, Executive Order 11246 regarding Equal Employment Opportunity in addition to other applicable State Laws.
