Notice is hereby given that the Housing Authority of Bergen County is seeking written sealed bids on behalf of the Bergen County Housing, Health & Human Services Center for the following:

The contract shall be awarded for a period of Two (2) Years beginning January 1, 2016 and expiring on December 31, 2017. The Housing Authority of Bergen County reserves the right to delete sections of the work from the Contract after the award of the bid had been made, due to funding or other reasons.

Bid documents, information and other instructions to bidders may be obtained in person at the office of the Housing Authority of Bergen County, at no charge, any business day between 9:00 a.m. and 4:30 p.m. at One Bergen County Plaza, Floor 2, Hackensack, NJ or by calling Drew Dorian, Purchasing Assistant at (201) 336-7627.

This bid is being solicited through a fair and open process in accordance with the N.J.S.A. 19:44A-20.4 et seq. Prospective bidders shall comply with the requirements of the Local Public Contracts Law N.J.S.A. 40A:11-1 et. seq. as supplemented and amended; Disclosure Notice (P.L.1977, c33) N.J.S.A. 52:24.1, and with the requirements of the P.L. 1975C.127 regarding Affirmative Action, Executive Order 11246 regarding Equal Employment Opportunity in addition to other applicable State Laws.

The Contractor shall be required to make a good faith effort to make provision for vocational counseling, training, and provide employment opportunities for the disabled and economically disadvantaged who are qualified to perform those functions for which the Contractor is hiring. The Contractor shall take into consideration the consumer's mental, physical, educational and financial limitations.

Special consideration will be given to contractors who promote the furtherance of the goals of the Rehabilitation Set Aside Act, N.J.S.A. 30:6-23 et seq., which allow for purchasing of goods and services from the non-profit rehabilitation sector, while heightening their efforts to assist in the productive employment of special needs individuals. The contractor shall provide evidence of the employment records for special needs individuals. The Authority is making great efforts to encourage the various vendors who will provide services to the Center to utilize qualified special needs persons to provide these services.

Bids for the contract must be made on standard forms in the manner designated therein and required by the specifications, and shall be submitted in a sealed envelope, bearing the name and address of the bidder, plainly marked to indicate the subject of the bid and addressed to the Housing Authority of Bergen County, One Bergen County Plaza, Floor 2, Hackensack, New Jersey 07601 by **12:30 p.m. Thursday, October 8, 2015**. Bids received after the deadline date and time will not be accepted.

All prospective Vendors are urged to make arrangements to visit the site to familiarize themselves with all the conditions affecting this work. Failure to visit the site will not release the Vendor of their responsibility to provide all the requirements of this project.

The Housing Authority of Bergen County reserves the right to reject any or all bids, or to waive any informalities contained therein. No bid shall be withdrawn for a period of sixty (60) days subsequent to the bid due date without the consent of the Housing Authority of Bergen County.

Notice of contract award will be given to the general public and to unsuccessful respondents within 10 days of the contract award.
